### 3. Report

#### A. President's Report

C. Uyeki: Feel free to read about appointments. I've sent several emails about the management search and selection committees – it's crucial that we fill the 2 designated faculty seats early to ensure the process takes place in a timely manner. Also see the email from this morning with coordinator positions open for the next 2 years. There are descriptions of all positions attached to the president's report. Some folks can be reappointed, but please express interest in any position. Going to try to fill all appointments before the end of spring. Contact Chisa if you want to know more about any of these positions.

Wanted to discuss national level events, including concerns about health care, privacy, and human rights for everyone, but especially those people with uterus in light of this week's events. Highlight a comment from K. Rivera: "I'm worried about my daughter growing up with fewer constitutional rights than I had and than my mother had." This is yet another trauma that we are moving through and our students are moving through as we try to do our daily work.

AMAC Faculty Equity in Hiring workgroup is moving forward on their work.

AMAC: mutually agreed to emergency hire for Cross Country Track and Field 1 year replacement. Also agreed for Nursing to hire 2 out of their pool instead of 1, they had a recent retirement and it will be more efficient to hire 2.

Also see results from Survey of students. About 1520 students responding to each question, though it varied slightly. White students slightly over-represented, Hispanic students slightly underrepresented. ~80% are comfortable being on campus this semester with both mask and vax mandates. More students would be uncomfortable if there were no Mask or vax mandate for fall 2022. ~50% still would be comfortable.

Which protocols should be present: nearly 80% of students chose one of (mask, vax, mask and vax). Only 21% chose "no protocols should be in place". 85% of students support continuing on-campus testing.

J. Christ: Did we ask the opposite question: if there were mandates in place, would you NOT take classes on campus? C. Uyeki: We tried to stay away from questions that would be seen as scheduling or enrollment questions. I agree that it is another question that comes to mind. All questions that we asked are included in this powerpoint.

S. Guth: Are we planning to make a recommendation? C. Uyeki: In action today we have a couple of related items. We could reaffirm our previous resolution. We could also consider making recommendations on safe learning environments informed by the survey data.

E. Woolery: Did you capture info on departments or class types? C. Uyeki: We did not show all the demographic details – we asked about participation in special programs. We took a quick look to see if students registered with ACCESS had different results, for instance. It wasn't identical, but the distributions were similar. Racial breakdowns were similar, but students who identified as white were slightly less interested in protocols, although it was not enough to shift things a lot. K. Rivera: We were trying to make a quick and easy survey that remained within Senate purview.

E. Woolery: online vs. face to face? C. Uyeki: We didn't ask about their current enrollment. E. Woolery: those who answered may be taking online or face to face? C. Uyeki: that's correct, or they might have multiple choices. S. Blacksher: they could reply that the question doesn't apply, so if they don't come to campus at all that was an option.

C. Uyeki: We also have confidence that there's no duplication – Qualtrics can remove those duplicates. We're glad we got such a good response, we think it speaks to students wanting to have their voices heard on these matters.

### D. 5 year Program Review Process

K. Allende: No additional context beyond that from the last meeting, unless anyone has questions.

M. McGuire (Question): Can I get a reminder of history? K. Allende: Last year Senate approved the process and said that if nothing changed in the program, there would be no additional info needed. Under the new administration in the instruction office, we've been told that even if there are no changes to a program, we would have to submit all the info to adhere the chancellor's office requirements as interpreted by the instruction office.

P. Wolf (Question): Is this a change in policy at the chancellor's office or is this a change in policy at the instruction office? That is, who is requiring all this work? K. Allende: It's the interpretation of the instruction office, their interpretation of title 5. I disagree as an individual, but the instruction office is saying that we have to do this for new and renewing programs. P. Wolf: As things stood, you could start a program and not revise it for 15 years and the chancellors' office would be fine with that. K. Allende: yes. P. Wolf: So as a senate we decided that it was a good idea to look at things again every 5 years, and the instruction office is interpreting this to mean we need to provide all the new info. K. Allende: correct.

M. McGuire (CON): This sounds to me like one more bureaucratic measure that takes time away from us doing our jobs of teaching our students. Not all schools have this much paperwork. All these additional processes give us less time to do the important job. We already have too much of this absurdity.
