<p><b>Discussion</b></p>	
<p>Academic Senate Workgroup formed on ChatGPT</p>	<p>This Academic Senate workgroup will provide policy recommendations, guidance, and teaching practices for faculty on the topic of AI and Education with a focus on the use of ChatGPT. Exec Board approved the formation of this workgroup with one abstention on March 2, 2023. They are aiming to issue recommendations in April.</p> <p>Proposed Membership: Raul Madrid, Sarah Nichols, Kelly Rivera, Andrea Diem (Philosophy), Elizabeth Lobb (Geography), Sohair Zaki (CIS), Monika Chavez (Library). Sarah Nichols says this is an informal group and therefore there is no set DL representative. Raul Madrid reached out to FCLT. Kelly, Andrea, Elizabeth, and Sohair teach online and Elizabeth is a member of the POOCR Team. This workgroup will push something out quickly and a task force may be formed to make formal recommendations, which DLC hopes will include a DLC member.</p>
<p>Noncredit ABE Online Training Needs and Proposal</p>	<p>Noncredit submitted a request for a new online training for short-term, High School Referral faculty. This Adult Basic Education (ABE) program has unique features that distinguish it from other distance learning classes, including having open entry/open exit, individually generated objectives (like an independent study), a required synchronous online office hour, and a high-school tool called Edmentum. Faculty have only a few weeks to train before being assigned to a class. The DLC agreed that this program was differentiated from usual distance learning options, and discussed how the training should evolve.</p>

It was noted that the FCLT supports tools such as HonorLock and Unicheck. Senate goals indicated this goal is fulfilled, however, request is for more information on how to find training.

DL Amendment Forms	Tabled until next meeting The current DL Amendment form process is conducted outside of WebCMS. Curriculum has requested that it be reintroduced into WebCMS again, but in a different way so that we don't run into the same issues we did before. Mt SAC's DL Amendment form is unique and its basic format has not changed in nearly 20 years. Before reintegrating it into WebCMS, we should examine the form itself to determine if changes need to be made.
