RE: Student Support Block Grant Allocations and Guidance

This memo provides an overview of the one-time Student Support Block Grant included in the 2025-26 Budget Act, outlines the funding formula used for allocations, provides guidance on allowable expenditures, informs districts of their allocations and expected payment schedule, and details the reporting requirements.

Background and Purpose of Funds

<u>Assembly Bill 123, Section 27</u>, as part of the 2025-26 California higher education budget trailer bill, establishes the Student Support Block Grant and appropriates \$60 million from the General Fund to the California Community Colleges to support the implementation efforts related to the <u>California's Master Plan for Career Education</u>, which shares many of the same <u>Vision 2030</u> goals, and strengthen supports for students.

The Student Support Block Grant is a strategic investment in student success and workforce readiness, emphasizing skills-based learning, career pathways, and student equity. It is designed to enhance existing student support programs and reflects a commitment to stability in higher education funding during a challenging fiscal period.

Funding Formula and Distribution Method

As outlined in <u>Assembly Bill 123</u>, <u>Section 27</u>, the following are the calculations used in determining each district's allocations:

- 1. Base Allocation: \$150,000 per college within each district
- **2.** Remaining funds distributed based on equal weighting of the following two measures for the most recent fiscal year in which the data is considered final (**2023-24**):
 - A) Total student headcount
 - B) Combined count of students receiving:

- California College Promise Grant (fee waivers under Ed Code §76300)
- Exemptions from nonresident tuition (under Ed Code §68130.5)

Payment Schedule

Funds will be disbursed through apportionments, beginning with the P1 Scheduled Payments in **February 2026.**

Spending Guidelines

The Student Support Block Grant funds may be expended for any of the following purposes:

- Assistance to students with food, housing, transportation, and other basic needs.
- Childcare subsidies or other assistance for student parents.
- Financial aid advising or academic counseling.
- Legal and other support services.
- Mental health services.
- Job placement, work-based learning, or reemployment support.

It is the intent of the Legislature that community college districts align the uses of the funds appropriated with **existing** student support programs, such as basic needs centers, mental health services, financial aid outreach and administration, Student Equity and Achievement Program, Guided Pathways, Hispanic-Serving Institution funded programs, and/or other equity-focused programs.

Community college districts have until **June 30, 2029**, to expend the funds.

Reporting Requirements

As a condition of receiving the Student Support Block Grant funds, community college districts shall submit an annual report to the Chancellor's Office including both of the following for the previous fiscal year:

- A summary of how the funds were used, including the types of services provided.
- The outcomes of the funds, including the number of students receiving each type of service and any available data on their academic outcomes.
