**RE:** Formal Notification of Related and Supplemental Instruction FY24-25 Initial Allocations

This memorandum is a formal notification of the initial allocation of related and supplemental instruction (RSI) hours funded by the FY24-25 appropriations. Upon appropriation by the Legislature, the Chancellor of the California Community Colleges (Chancellor) is responsible for allocating funds for apprenticeship programs in good standing and approved pursuant to Chapter 4 of Division 3 of the Labor Code consistent with subdivision (e) of Education Code Section 8152 or 79149.3 to reimburse RSI maintained by a school district, a county office of education, or a community college (collectively referred to as LEAs).

In FY24-25, the Legislature appropriated a total of \$95,540,000 for RSI reimbursement. This is an overall increase of \$2,099,000 million from FY23-24. The FY24-25 schedule breakdown is as follows:

Of the funds allocated to Schedule 3, K12 LEAs, a total of \$1,133,000 will be used to reimburse apprenticeship programs for eligible related and supplemental instruction hours from FY21-22 and FY22-23, as indicated in the 24-25 Budget Act.

The increase in the RSI appropriation was dedicated to increasing the hourly rate of RSI funding from \$9.98 to \$10.05. The FY24-25 allocation amounts are based on Projected hours reported by LEAs in FY22-23. Therefore, an adjustment to the number of reimbursable hours for each schedule

will be made during ReCal. A list of LEAs and their FY24-25 initial allocations is included in this memorandum, starting on page 3.
