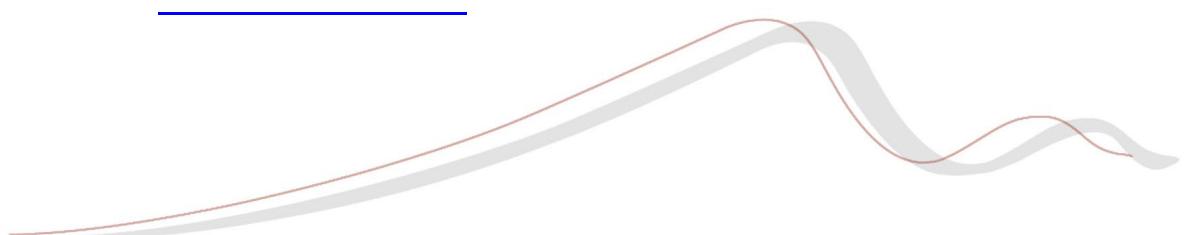

4. Cabinet reviewed the [Basic Fire Academy Application Process](#) that was reviewed by AMAC on February 9th. Applications will be accepted for the Spring cohort through the end of the third full week of September preceding the Spring semester. Applications will be accepted for the Fall cohort through the end of the second full week of March preceding the Fall semester. There are three applicant eligibility tiers that are dependent on the student's completion of coursework, and the first 60 applicants are guaranteed an invitation to the Entrance Exam. If more than 60 applicants remain after the Entrance Exam, placement will be based on the applicant's registration date and time.
