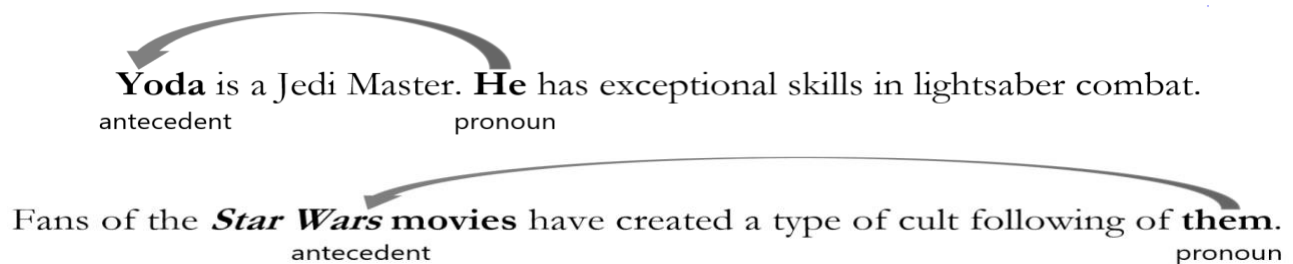

Understanding Pronoun-Antecedent Agreement

Terms to know or review:

- **Pronoun:** a word that substitutes a noun
- **Antecedent:** the word or words that a pronoun replaces

Why do we have problems with pronoun agreement?

Language evolves and it has been proposed that usage may change pronouns like *everyone* from singular to plural in the near future. We run into problems with pronoun agreement because we hear this error all of the time on the radio and in live news broadcasts; however, pronoun agreement has quite a simple concept:

A pronoun agrees with its antecedent in person, number, and gender.

Read the following sentences and **highlight** the pronoun that agrees with its antecedent.
